### PROSECUTOR'S SEVENTH PROGRESS REPORT

- Pursuant to the Referral Bench's Decision on Referral of Case Under Rule 11 *bis* with Confidential Annex ("Referral Decision") of 27 April 2007, the Prosecutor hereby files his seventh progress report in this case.
- 2. The Decision on Referral ordered:

...the Prosecutor to file an initial report to the Referral Bench on the progress made by the Prosecutor's Office of Bosnia and Herzegovina in this case six weeks after transfer of the evidentiary material. Thereafter, the Prosecution shall file a report every three months. These reports shall include information on the course of the proceedings before the competent national court after commencement of trial, and shall include any reports or other information received from any international organisations also monitoring the proceedings.

- 3. The sixth progress report in the *Trbić* case was filed on 23 October 2008.<sup>2</sup>
- 4. Following the agreement between the Chairman in Office of the Organisation for Security and Co-operation in Europe's Mission to Bosnia and Herzegovina (the "OSCE") and the Office of the Prosecutor ("OTP"), the Prosecutor received OSCE's sixth report on 19 January 2009.<sup>3</sup> The Report outlines the main findings of trial monitoring activities to date in the *Trbić* case, from the perspective of international human rights standards.

OSCE's Sixth Report in the *Milorad Trbić* Case Transferred to the State Court pursuant to Rule 11 bis, January 2009 ("Report").

- 5. The OSCE has not noted any issues of concern from a fair trial and human rights perspective during the reporting period.<sup>45</sup>
- 6. The OSCE summarises the proceedings in the *Trbić* case to date as follows: <sup>6</sup>
  - The Court held six sessions and heard the testimony of three witnesses one expert for the Defence and two additional witnesses for the Prosecution who all testified in public sessions.
  - The Defendant remains in custody on the basis of the risk of flight and threat to public security pursuant to a decision on 6 January 2009.<sup>7</sup>
- 7. Moreover, OSCE mentions the proactive conduct of the Court in seeking to clarify and rectify an erroneous statement made by POBiH to the media, which it deemed could have resulted in prejudicing the *Trbić* case. The Deputy Chief Prosecutor in an interview stated that based on the presented evidence in Trbić trial, the POBiH discovered three new mass graves. After the publication the Trial Panel invited the Deputy Chief Prosecutor to appear before the Court concerned by the fact that the erroneous statement could prejudice the Trbić's case. In response, the Deputy Chief Prosecutor drafted a letter in which he apologised for his error. On 27 October 2008, the Court confirmed with the Prosecution that acknowledgement of the mistake was made public and, by doing so, satisfied itself that the error had been duly addressed.<sup>8</sup>
- 8. The Prosecutor takes note of OSCE's Report and has no other information to bring to the attention of the Referral Bench.
- 9. Attached to this report is a copy of the OSCE's Report.

#### **SUMMARY OF DEVELOPMENTS**

The case of Milorad Trbić (hereinafter also Defendant) is the sixth case transferred from the ICTY to the BiH State Court pursuant to Rule 11bis of the ICTY Rules of Procedure and Evidence (RoPE). This constitutes the sixth report in this case that the OSCE Mission to Bosnia and Herzegovina submits to the ICTY Prosecutor, covering the period of 10 October 2008 to 10 January 2009.

During this reporting period, no concerning issues from the perspective of human rights were noted. Thus, this Report summarises recent developments and provides a list of the relevant hearings, submissions, and decisions. It also includes reference to an instance where the Court proactively sought to resolve, and indeed did so, an erroneous statement made to the media, which it deemed could have resulted in prejudicing the *Trbić* case.

The proceedings of this reporting period can be summarised as follows:

- The Court held six sessions, during which it heard testimonies of three witnesses one expert for the Defence and two additional witnesses for the Prosecution. Hearings and status conferences were held mainly in public. None of these witnesses testified with protective measures.
- The Defendant remains in custody based on the risk of flight and threat to public security pursuant to a decision dated 6 January 2009.
- The next court session is scheduled for 12 January 2009.
- It may be interesting to make reference to the proactive conduct of the Court in seeking to clarify and rectify an erroneous statement made to the media. On 7 October 2008, the Trial Panel requested the Deputy Chief Prosecutor to appear before it to discuss a statement he made to the Balkan Investigative Reporting Network (BIRN) in an interview with BIRN published on 19 September 2008. This article reported that the Prosecutor's Office had yielded success when, "on the basis of presented evidence in Milorad Trbic's trial, it discovered three new mass graves, which were excavated last summer."

Following the article's publication, the Court noted that the statement of the Deputy Chief Prosecutor was mistaken. The Prosecutor's Office did not discover three mass graves based on evidence from the Trbić case but from a different State Court case. Concerned by the fact that the erroneous statement could prejudice the Trbić case, the Trial Panel invited the Deputy Chief Prosecutor to appear before the Court.

In response to the Court's request, the Deputy Chief Prosecutor drafted a letter on 13 October 2008 in which he apologised for his error and informed the Court that he had notified BIRN of his mistake. On 20 October 2008, BIRN published an article on the Trbić case in which it indicated receipt of the Deputy Chief Prosecutor's letter and included a link to this letter.<sup>3</sup> On 27 October 2008, the Court confirmed with the Prosecution that acknowledgement of the mistake was made public and, by doing so, satisfied itself that the error had been duly addressed. BIRN subsequently published an article on the 27 October 2008 noting these developments.<sup>4</sup>
